Mr. Claybrook:

I have not received a response to my email below. Please be advised that the bank is not authorized to transfer any funds owned by TopDevz, LLC to Mr. Rajae, based on these orders and instructions of Mr. Davis.

Please be further advised that on the morning of January 7 Mr. Davis put the bank on notice of the fraudulent transfers of January 6 and 7. I am informed that the bank allowed the wire to Mobile Monster of about \$131,000 to be sent, despite Mr. Davis' objections on behalf of TopDevz and despite the bank's knowledge or the illegality of the transfer. I am also informed that the two \$450,000 transfers totaling \$900,00 from January 6th have not been reversed or frozen, despite the fraud warnings of TopDevz.

Mr. Rajae has locked Mr. Davis employees of TopDevz out of the electronic data of TopDevz, and Mr. Rajae has apparently told third parties that he is diverting TopDevz business to his own entities to the detriment of TopDevz.

Please respond promptly to advise that the has done and will do to preserve TopDevz' deposits from these actions.
